It is our pleasure to inform you that AICTE being one of the 9th National Coordinators for SWAYAM MOOCs has offered Twelve (12) online Yoga Credit Courses on SWAYAM Platform for enrollment by all aspiring learners during July, 2023 Semester. The examinations for these Yoga Credit Courses have been scheduled to be conducted by NTA on 30th November, 01st & 02nd December, 2023. The enrolment for these credit courses has already started from 2nd week of July, 2023. Registration for examination of these Yoga Credit Courses would be announced in due course of time. The University Grants Commission notified the UGC (Credit Framework for Online Learning Courses through SWAYAM) Regulations, 2021 during March, 2021 which facilitates an Institution to allow credit transfer up to **40% of the total courses** being offered by any higher education institution in a particular programme in a semester through online learning courses on SWAYAM Platform. **AICTE has also adopted the credit transfer up to 40% on UGC pattern in continuation of AICTE (Credit Framework for Online Learning Courses through SWAYAM) Regulation** and has already requested all Universities / Colleges, from time to time, to allow credit transfer up to 40% of the total courses being offered in a semester through SWAYAM. As per Para 4.1 of UGC (Credit Framework for Online Learning Courses through SWAYAM) Regulations, 2021, the schedule of the SWAYAM based online credit courses shall be aligned with the conventional education semester commencing in the month of January and July of every year.



Education All Institutions/Universities/Non-Technical Technical Higher Universities are, requested to give wide publicity to the above Yoga Credit Courses in their respective Institutions and to explore the feasibility for credit transfer in respect of these Yoga Credit Courses as per University Grants Commission (Credit Framework for Online Learning Courses through Study Webs of Active Learning for Young Aspiring Minds) Regulations, 2021 adopted by AICTE.
